Each entrant will need to bring with them an insurance policy rider that lists Jeffco Fair, Inc. dba Jefferson County Fair, as insured for this event (we will need a copy for our records).

Because the show has a capacity of ONLY 75 vehicles for each day, no entrant beyond that number will be accepted.

All Registrations must be received no later than July 15, 2011 (no registration accepted on the day of the event).

All entrants will receive a ticket PASS that will allow them to enter into the area for this event; no entrant (Cars) without pass will be allowed to enter this event area.

MOVE IN

Cars will be placed at show official's discretion between the hours of 10am and 11:30am on August 13th and 14th Cars that are registered for this event that wish to park together (if possible) must arrive together.

AWARDS

Entrants will be judged by "Peoples Choice", and "Judges Choice", both receiving trophies, 2nd, and 3rd place ribbons will be awarded for runner-ups.

END OF SHOW

At end of show for each day and no later than 6pm, unattended vehicles will be towed at the owners expense.
